8. Resolution to Approve the 2040 Master Plan – all Board Members have a copy of the plan – Supervisor Smith read the Resolution for the Public.

#### **RESOLUTION #23 - 207**

Mr. Stevens made a Motion to approve the 2040 Master Plan and moved its passage with a Second Motion from Mr. Hoskins. With the following members present voting in favor of the Resolution it is carried. Ayes – 5 (Smith, Gonyo, Stevens, Arsenault, Hoskins); Nays – 0. Mr. Hoskins - for the record we received a letter from Bone Bayse – Gore and ORDA approve of the plan as well.

9. Resolution Approving Tentative Vision for 2040 Work Schedule – Supervisor Smith - broken down into 4 phases; Mr. Gonyo – this resolution commits us only to the work outlined in the phases, this does not tie us to any monetary obligation? Supervisor Smith – correct.

#### **RESOLUTION # 23 – 208**

Mr. Hoskins made a Motion to approve the Tentative Vision 2040 Work Schedule and moved its passage with a Second Motion from Mr. Stevens. With the following members present voting in favor of the Resolution it is carried. Ayes -5 (Smith, Gonyo, Stevens, Arsenault, Hoskins); Nays -0

10. Resolution to Appropriate Funds for the Partial Phase 1 Design Work – Supervisor Smith – this is another engineering thing; \$100,000 of fund balance into an account for the engineering work; AS/PH; Mr. Gonyo – I would vote to table this until the budget has been finalized; we're still adjusting numbers and we don't know how it will affect the reserve funds; Mr. Gonyo – motion to table Mr. Stevens -sound reasonable; Supervisor Smith – I think we need to get a better handle on this and how much we can afford to put into this; I think it's a good idea, but I can see the merit in not overextending ourselves.

#### **RESOLUTION # 23 – 209**

Mr. Gonyo made a Motion to table this until after the Budget has been finalized and moved its passage with a Second Motion from Mr. Stevens. With the following members present voting in favor of the Resolution it is carried. Ayes -5 (Smith, Gonyo, Stevens, Arsenault, Hoskins); Nays -0.

11. Resolution Establishing a Reserve Fund for 2024/2025 Assessment for Re-val – Supervisor Smith – this is for a 3<sup>rd</sup> party contractor; this is the right thing to do at this time. \$300,000; Mr. Stevens – why would we table a \$100,000 and spend \$300,000; Mr. Hoskins – it's a lot of money to assure confidence; Mr. Gonyo – we were looking at this earlier on; Mr. Hoskins – we can do a re-val for less than \$300,000; Mr. Arsenault – aren't' we required to update our information; Supervisor Smith – 3 years; I would wait until 2025, but if not 2024 would be the year; Mr. Gonyo – we're already a year into it; Supervisor Smith – we could slide until 2025; take half now and half later; Mr. Arsenault – hesitate to put that amount of money aside, not in favor of it; Mr. Gonyo – it's a year and a half if we wait; I'm looking at this from the standpoint of the park is not a need; Mr. Hoskins – it's a waste of money, we can do it in-house; Mr. Gonyo – if we don't set these funds aside, it's an expense we have to bear; Mr. Hoskins – it's a lot of money that we don't need to spend; Supervisor Smith – assessor would rather have a third party do it this time; Mr. Gonyo – that number was based on the most expensive quote from 3 different firms to conduct the re-val; Mr. Hoskins – you're not getting much for it, total waste of tax payers money; Mr. Gonyo – we need to keep our commitment to the State that was made previously made; set \$150,000 to conduct the re-val in the future; Mr. Gonyo – let's amend the resolution to \$150,000. Supervisor Smith – yes.

#### **RESOLUTION #23 - 210**

Mr. Gonyo made a Motion to amend the Resolution to be \$150,000 now and \$150,000 next year for the  $3^{rd}$  Party Re-val and moved its passage with a Second Motion from Mr. Stevens. With the following members present voting in favor of the Resolution, it is carried. Ayes -3 (Smith, Gonyo, Stevens); Nays -2 (Hoskins, Arsenault).

12. Resolution to Extend the Memorandum of Authorization by and between LCLGRPB – Supervisor Smith - remediation at Ski Bowl Resiliency may take longer than anticipated; this extension would be at a cost of \$7,500.

#### **RESOLUTION # 23 – 211**

Mr. Stevens made a Motion to approve the MOA with LCLGRPB for the Ski Bowl Resiliency Project and moved its passage with a Second Motion from Mr. Hoskins. With the following members present voting in favor of the Resolution it is carried. Ayes – 5 (Smith, Gonyo, Stevens, Arsenault, Hoskins); Nays – 0.

13. Lights on Occupancy Tax Money – Supervisor Smith – we had a private donor that had done this in the past; Mr. Olesheski would like to amend the amount for an additional \$100 for prizes to the float winners. – total would be \$1,000.

Mr. Hoskins made a Motion t approve the \$1,000 from Occ Tax for the Lights On/Prize and moved its passage with a Second Motion from Mr. Gonyo. With the following members present voting in favor of the Resolution it is carried. Ayes -5 (Smith, Gonyo, Stevens, Arsenault, Hoskins); Nays -0.

14. Resolution to Repay Warren County – Supervisor Smith – there was a Warrant Error in 2021 from the County (\$10,000) their error, it would come from Fund Balance.

Supervisor Smith the Assessor will get this out; when you get your letter, please come down and apply; bank statement or income tax; fixed income bank statement for 15 days.

19. Resolution to Replace the Boiler System at the Highway Garage – Supervisor Smith – this is an emergency situation at the point; parts are not available for this system as it is so old. Part of this Resolution would be to approve 50% down. Mr. Konis – did you try Tempheat? Supervisor Smith – no this needs to be replaced as soon as possible.

24. Committee Reports – Mr. Gonyo - Personnel Committee and Planning Committee met and had an interview for a ZEO; a good fit for the job; we were going to bring the recommendation to hire this

individual; he wanted to increase the salary; we've already done that for a full-time position; revisit job description and put back out for advertisement or talk about adjusting the salary again; \$60,000, we're at \$42,000; Supervisor Smith – at \$60,000 they would be the highest paid person in town; this is the problem that will become more and more frequent; I don't think we can do \$60,000 at this time; it needs to be a full time position; Mr. Gonyo – we increased the salary as well once; Supervisor Smith – it's a competitive salary for around here; re-advertise? Mr. Gonyo – we can't even come close to that \$60,000, a modest adjustment will not close the deal; 4-5 month advertisement – only a couple viable candidates; keep salary as is and move back to part-time, 3 days a week; would not have to pay benefits; Mr. Hoskins – raise the salary a little and see what happens; Supervisor Smith – we'll put back to 3 days a week and the individual will have to manage time better; – let's offer this to the candidate and see what happens. Supervisor Smith – all OK with that, all good.

25. Warrants – Supervisor Smith – I have gone through all, accurate; Mr. Gonyo – voucher 795? Clarified by Supervisor Smith. Can I get a Motion to accept?
