WHEREAS, The Johnsburg Director of Public Property & Programs has identified a serious concern with the exterior painting of the building, including completely bare trim/fascia/soffit and roof slides, and WHEREAS, The Town of Johnsburg has previously promised to complete this much needed maintenance when practical, and

WHEREAS, The Johnsburg Director of Public Property & Programs has received three written quotes for the necessary work, in accordance with the Town's procurement policy and Adirondack Paint and Paper LLC offers the lowest quote,

NOW THEREFORE IT BE RESOLVED The Town of Johnsburg Town Board authorizes the Director of Public Property & Programs to contract with Adirondack Paint and Paper LLC to pressure wash and paint the exterior of Tannery Pond Community Center as soon as weather allows in the spring of 2025, at a total cost of \$30,950.00, and

NOW THEREFORE IT BE RESOLVED The Town of Johnsburg Town Board authorizes the Director of Public Property & Programs to contract with Beaudoin's Hardwood Flooring to sand and refinish the auditorium floor of Tannery Pond Community Center in 2025, as soon as both the vendor is available and the auditorium is unscheduled for a period of at least two weeks, at a total cost of \$13,754, and

LET IT BE FURTHER RESOLVED That The Town of Johnsburg Town Board authorizes the encumbrance of funds from the 2024 A1620.41 budget line, in order to cover this expense.
