#### **RESOLUTION #89 – 24**

Ms. Bowers made a Motion to accept and approve the Town Board Meeting Minutes from April 16, 2024 and moved its passage with a Second Motion from Mr. Heid. With the following Members voting in favor of the Resolution it is carried. Ayes – 5 (Bean, Bower, Heid, Stevens, Williams).

4. Resolution for Special Event Permit for September 21, 2024 Community Day and Outdoor Show at Tannery Pond

# **RESOLUTION # 90 – 24**

Mr. Stevens made a Motion to approve the Special Event Permit for the Community Day and Outdoor Show on September 21, 2024 at Tannery Pond and moved its passage with a Second Motion from Mr. Heid. 9. Resolution to Pay J&K Trucking – Supervisor Bean – per the contract we need to pay on the 1<sup>st</sup> of the month; Geoff Konis – where is the tank? Just concerned about transporting it and insurance; make sure it's insured by the Contractor before shipment; Supervisor Bean – I hear what you're saying; this is for the tank; Mr. Heid – need to establish ownership; Mr. Williams – wondering why we were making an exception in this case in expediting a payment; I reviewed the contract; engineer is on site daily to inspect the project and signs off each day; engineering firm to bill the town; money is in our hands from the Grant.

# **RESOLUTION # 95 – 24**

Mr. Stevens made a Motion to approve the payment to J&K Trucking as indicated in the Contract and moved its passage with a Second Motion from Mr. Heid. With the following Members voting in favor of the Resolution it is carried. Ayes – 5 (Bean, Bower, Heid, Stevens, Williams).

10. Resolution to Place an RFP for the Scales at the Transfer Station – several of us met with the rep from the scale company; not much re-arranging; in conversation with SLIC re: electrical; small scale now that will be in place for household garbage, just for research and information at this time; want to track where we're at; Mr. Heid – have you reached anyone at SLIC yet? Supervisor Bean – yes, spoke with CFO recently; Mr. Williams – we have \$50,000 for revenue coming in from trash, first 4 months we've brought in \$2,000; it's imperative to do this; Kelly Nessle – very concerned about the scales being put in and it is park land and it's a concern of mine; Mr. Heid – my understanding is that the scales can be moved quite easily.

#### **Paul Heid**

Solid Waste - looking at scales; have Hoosick Tires ready to come and pick up; they try to be very environmentally friendly; the price is very cost effective; I've used them at my business and they are very easy to work with; was expecting Mr. Hoskins to be here; Mr. Williams – we've moved forward with the RFP for the scale; Mr. Heid – scale will be below budget. Roger Mosher – will residents still have to pay to get rid of their tires? Mr. Heid – yes and we have to pay to have them removed but at a lower cost.

#### **Anna Bowers**

- Personnel nothing; ADK Birth to 3 Foundation looking for some funding and grants.
- Marketing gateways into each Hamlet; good meeting; sign at Ski Bowl needs to be redone.
- Planning & Zoning triage our Zoning laws; Roger Mosher how can the Town violate it's own Zoning laws when I can't?
- Comprehensive Planning Workshop good meeting; new faces; would like to see more people; great discussions; where to hold the next workshop[?
- Occ Tax discussion done; December 1, 2024 is the next round;

#### Jim Williams

- Completed refurbishment of trails behind the transfer station; UHTA had a meeting re: erosion affecting the trails and repair from last year's construction; they seem to have a pretty strong plan.
- ORDA Construction Navigating through the water hookup for the new Lodge; preliminary approval of this; restoring power to the concession stand – ORDA working on it; AB – time line on that; JW – we made it very clear last Wednesday that it needs to be a short time line.
- Sewer Committee Round 3 of comments; they will be ready to resubmit tomorrow morning; working on easements;
- The Longest Day Race getting closer; they have worked with ORDA and the Town re: insurance;

## Arnold Stevens

Water committee – already gone over that; water mitigation at Ski Bowl – had a
meeting; all moving along quite well, Mr. Jones and the Engineer are satisfied; North
side there are some high voltage lines in an inappropriate area, we're trying to reconcile
this with National Grid.

# 18. Privilege of the Floor -

- Deana Wood thank you to the Occ Tax Committee; explained the purpose of JHS; turning the garage into a display area; we'll start working on this in June; a map room is getting done as well; celebrating the people of Johnsburg; a lot going in; very thankful for the monies; 6/1/24 grand opening; just stop by and see it;
- Arthur Webb helping to build a coalition to save the Nursing Home; meeting here at TPCC, some of the owners of Elderwood will also be here; we're doing a banner as well; it's a pivotal resource; it's essential to have it here; the Governor needs to help it get stabilized; helping build the advocacy, it's important, the outpouring has been fantastic. Meeting at 6:00PM on Thursday 5/16/24.
- Roger Mosher I'd like to go over some issues; 1) Nessles should pay reparations to the people of the Town for their spending of tax payer money; 2) how has ORDA helped this Town; re-negotiate the agreement with ORDA; put me in charge of negotiations; 3) \$40,000 for use of our Land; Stevens and Arsenault sold for \$1; State will take our park though eminent domain; I urge the Board to re-negotiate the agreement; taking Ownership of the Mosher Garage Property is not a good a idea; make sure DEC sends us a letter of; Kate Nightengale stated the wells were tested and no contamination, I spoke to DEC and only one well was tested; no other person dares to speak what I have to say list of people responsible for the problems in Town ORDA, Front Street, etc.
- Kelly Nessle I feel it's pretty unfair to lay the ORDA project at this Board's feet; it's just coming to fruition as Government works slowly; is it ideal or perfect – no; where would this community be without the input from the State; don't blame this Board, they're just getting started.
- John Sleckman you have a very unusual situation where the State is building on Town
  property and this could come back to bite us later on; renegotiate the Agreement with a
  good attorney; Ski Bowl Park will not be useful in the future. I echo what Roger Mosher
  said and you should listen to him, he's a smart man.
