1. Call to Order the Regular Town Board Meeting at 7:14 PM

2. Approve the Meeting Minutes of December 20, 2022

# **RESOLUTION #23 - 11**

Mr. Stevens made a Motion to approve the Meeting Minutes from December 20, 2022 and moved its passage with a Second Motion from Mr. Arsenault. With the following Board Members present voting in favor the Resolution is carried Ayes – 3 (Stevens, Arsenault, Hogan); Nays – 0; Abstain – 2 (Gonyo, Hoskins)

#### 3. Old/New Business:

a. EMS Contract – Supervisor Hogan indicated that the only change were the dates and is looking for approval of this Contract.

#### **RESOLUTION # 23 – 12**

Mr. Gonyo made a Motion to approve/accept the EMS Contract with the change in dates and moved its passage with a Second Motion from Mr. Hoskins. With the following Board Members present voting in favor the Resolution is carried Ayes -5 (Gonyo, Hoskins, Stevens, Arsenault, Hogan); Nays -0.

b. Local Law allowing first responder exemption – Mr. Gonyo noted that we spoke about this at the last meeting; it's a whole lot of work that needs to be pulled together for a fast approaching finish line; since the last meeting, Bruce Dunkley has reached out to us, fire departments have agreed to help as well; we have rosters and need to get to Assessor to crunch numbers; attended a meeting at Riverside with Bruce Dunkley; they're drafting a letter to see us move ahead with this in this year; I believe it's important to our volunteer fire fighters; it's complicated and stringent to be a volunteer; if a fire fighter should pass it would be to their spouse; I did let them know we need their assistance and a tight time line; would like to see if we can pull this through for our EMS and fire departments; Supervisor Hogan - town attorney has not read the law, he's willing to and he will get back to us; years of service is a concern, continued exemption is optional (i.e. widower, etc.); assessor crunching numbers, do we have lists? Mr. Gonyo the only missing North River; we're looking at 43 names; Supervisor Hogan - assessor will evaluate, what would be the burden on the tax applications, if we take 10% off each bill, all others will take on that 10%; Mr. Heidrich is this for school and town? Supervisor Hogan noted that the school would have to pass their own and we'll work on the Town portion of it; some of the other considerations are time to sign up, do we have to meet the March 1 deadline? All will need to be on board and we're counting on fire departments to do this; what about the EMS? We need their list as well; we've got a lot to learn, we'll do whatever we can to move it along; Mr. Hoskins should we not be able to do this in the time required, might there be alternatives rather than lose a whole year? Supervisor Hogan - we're still checking on the March 1st deadline;

there is another exemption that I don't know anything about, but it would still require a local law; Mr. Hoskins - it would be something to think about; Mr. Stevens - what is the latest we can take action on this? Supervisor Hogan - attorney is looking into this for us; if March 1st is the deadline I don't think we'll have enough time to get people signed up; set up Public Hearing at next Board Meeting and hold at the following meeting; we don't have anything from the attorney. Bruce Dunkley - thank you for your time; last night at the meeting I went over several points; they see this as a three-prong benefit - recruitment, retention benefit and protection benefit; property tax exemption - 10% exemption on assessment; March 1st is critical; the Senate and Assembly and the Governor's signature unanimously; this is a strong law to get that many people in the State to agree to it; it's a two page law; 2-5 year service, over 20 years - eligible to receive life time reduction; looking at my roster, we comprise 244 years of service to the community; 2 recent new members; other rosters are very similar; one individual has been in for 51 years; the Town Board has the option to make it available to widowers only if the individual was a current member of this; came out 12/15/22 - surprised our attorney hasn't read the law; the application has to be in by March 1st; it's a one page application; assessor would have to sign off; we reviewed the application last night, version as of 1/2/23; can view and fill out on-line; then turned over to the County Real Property with the tax roll; it's a local law that requires local action; the County really doesn't have a say in this whether the Town approves this or not; it's critical enough to move forward quickly and I respectfully ask the Board to do so; thank you very much for the time and opportunity to explain our position; Ms. Nessle - no volunteers with EMS, they are paid on-call; Mr. Gonyo – I'll hold off on getting that list then. Mr. Stevens – can they be considered for this exemption? Can we ask our attorney? Mr. Hoskins - do they get a W2? Ms. Nessle - I'd have to ask that; drivers are paid, that's the only way we could get drivers; Supervisor Hogan – any other questions or thoughts to pass along to the attorney; would like to have a Public Hearing Order for the next meeting.

- c. Sewer project Supervisor Hogan noted that the project is out to bid and due back to Town Hall by early February.
- d. Water District repairs Supervisor Hogan indicated that we're going out to bid for this as well; Mr. Stevens meeting today discussions centered around our policies and charges that need to be re-visited; Supervisor Hogan a lot of progress made on this today; water clerk is a ball of fire and ready to work with us; hasn't been raised in 15 years, small raises but not based on the needs of the district.
- e. Occ Tax Supervisor Hogan we have not opened the process yet; hoping to get the \$15,000 back from the County; no exact numbers right now; we can open the process to receive applications; all good with that; 6 weeks, mid-February to get applications in.
- f. Budget resolutions Supervisor Hogan noted the budget line transfers as follows:

- 1. Resolution to authorize end of year budget line transfers as necessary to close the 2022 fiscal year; a complete list of changes will be provided once the year is closed.
- 2. Resolution to authorize \$8,943.90 be moved from DA231 Equipment Reserve to DA5130.2R to be used for the balance due on the 2 new Western Star trucks.

#### **RESOLUTION #23-13**

Mr. Gonyo made a Motion to approve the Budget Line Transfers and movement of money from DA 231 (Equipment Reserve) to DA5130.2R and moved their passage with a Second Motion from Mr. Hoskins. With the following Board Members present voting in favor the Resolution is carried Ayes -5 (Gonyo, Hoskins, Stevens, Arsenault, Hogan); Nays -0.

3. Resolution to authorize the balance of the Bond and the interest accrued in the amount of \$418,908.70 to be paid to Tracy Road Truck Sales for the two Western Star trucks that have been delivered.

Committee Reports Mr. Gonyo spoke with John at Gore Mountain Village moving ahead with Town Water; they need to submit an application to DOH; need to list the Town on the application as a borrower; I called him to get clarification we'd be a pass through entity, they can't receive these funds, it would have to go through the Town to get to Gore Village; we need some type of letter as to what we're doing; I told him it would be discussed at the meeting tonight and he's working on the letter; no need to take any action tonight; Supervisor Hogan get us the letter; point of contact should be the Sewer Committee; need a temporary hookup fee application at the next meeting; no full engineering yet; what monies are they referring to; Mr. Gonyo water project grant application to the DOH; complete an intended use plan, etc.; Supervisor Hogan are they under a consent order? Mr. Gonyo I don't believe so.

#### 7. Privilege of the Floor

- Mr. Heidrich I'd like to thank Fred & the Highway department for the hard work on the last two storms. Sidewalks in Town are hideous, people walking in the road, cars are parked in snow; with the 2023 games coming up, we need to take care of this. Supervisor Hogan local law for opposite side of the street parking, we need to enforce it; called the County DPW Superintendent - he is looking into that. Mr. Heidrich - handicapped parking on streets, elderly need this; Supervisor Hogan - no businesses wanted it in front of their businesses; Mr. Hoskins – is the Town responsible for the streets? Supervisor Hogan – the road is County maintained, not sure what the owners responsibility is; the Town has struggled with it; the previous Highway Superintendent purchased a piece of equipment that immediately broke down and nothing was done; an outside company was helping, it was not looked upon favorably; we've struggled with this for years; how do we buy a piece of equipment and hire people to run it; we can't just maintain Main Street, we'd have to do all, in the entire Town; Mr. Gonyo - the gaps where there is no building; who owns what is part of the problem; Mr. Heidrich - old town I lived in, it was the responsibility of the owners or they were fined; Mr. Gonyo - 30-40 years, won't get solved tonight; what are we going to do? Supervisor Hogan - spoke with Mr. Hajos at the County today and talked to the Sheriff's office to get cars towed.
- Mr. Dunkley one more important point re: the volunteer exemption called the School will be meeting with the School Board Monday 1/9/23 and Mr. Gonyo will be attending with me; Mr. Gonyo could we extended the invitation to Mr. Stevens as well? Absolutely.

- Mr. Nessle about the sidewalks our sidewalks are cleaned by an individual; years ago the Town/County used to dump their snow on our vacant lot, it was fine; we didn't complain; if you need to get cleaned up for the games, dump on the lot. Tax relief for the volunteer people is absolutely wonderful and should be down as soon as possible; the law as it was written in this economy there are multi-million dollar homes being built, our volunteers live in \$100,000 homes; the rich guy and the poor guy are putting in the same time; why is the rich guy's time more valuable; there's inequity there. Intersection at Durkin Road and Route 28 it's highly used because of Stewart's, engineering work should be done; can the intersection be done differently at a 90 degree angle, easier to maintain the road and the shoulders; it would be much safer. Thank you Pete (Mr. Hoskins) for your Public Service in your previous position. Now is a good time for the Town Board to very seriously discuss term-limits; it's time for term limits so that the problems in the Town are dealt with on a more reliable basis, keeping up with the modern times, population, needs.
- Ms. Nessle thank you to the Board for your decision to appoint Mr. Olesheski as Parks/Rec
  Director; he's going to do a marvelous job; lots of good ideas about the Park; have met with
  him and nice to have him in the Park.
- Michael Wilson thought I should bring up the sewer system at the apartment building on the corner of Main & Wade is starting to smell.
